
FIRST AID

HAZARDS TO HUMANS.
CAUTION. Harmful if swallowed. Wash hands thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco, or using the toilet.
HAZARDS TO DOMESTIC ANIMALS
For external use only. **FOR USE ON DOGS AND PUPPIES ONLY.** Do not use on dogs or puppies less than 23 pounds or on puppies under 8 weeks of age. **DO NOT USE ON CATS OR OTHER ANIMALS.** Keep cats away from treated dogs for 24 hours. If applied to a cat or ingested by a cat, contact your veterinarian. Individual sensitivities, while rare, may occur after using **ANY** pesticide product. Dogs may experience some temporary irritation at the site of product application. If signs persist, or become more severe within a few days of application, consult a veterinarian. If your dog has an unusual reaction to the initial application, consult a veterinarian before repeating treatment. Certain medications can interact with pesticides.

SIDE EFFECTS
Monitor your dog after application. Side effects may include skin irritation such as redness, scratching or other signs of discomfort. Gastrointestinal signs such as vomiting or diarrhea have also been reported. If these or other side effects occur, consult your veterinarian or us at 1-800-691-7554.
DIRECTIONS FOR USE
It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.
Do not allow children to apply product.
To kill adult fleas, flea eggs and larva, chewing lice, all stages of **Brown dog ticks, American dog ticks, Lone Star ticks, and Deer ticks** which may carry Lyme disease, and to aid in control of sarcoptic mange mites, apply this product **ONLY** to dogs and puppies 8 weeks or older weighing 23-44 lbs. as follows.

Do not use on cats, rabbits, or other animals. Do not use on puppies under 8 weeks of age and less than 23 lbs.
Do not allow your dog to ingest this product. Do not apply more frequently than once every 4 weeks.
Do not apply more than one applicator per treatment for one dog regardless of the dog's weight.
Do not bathe or allow your dog to swim for 24 hours after application.
SteelCoat Plus™ For Dogs contains the active ingredients fipronil and (S)-methoprene that effectively target fleas, ticks and chewing lice. SteelCoat Plus™ For Dogs is fast-acting, long-lasting, waterproof, and easy to use. Steel Coat Plus™ For Dogs remains effective even after bathing, water immersion, or exposure to sunlight. SteelCoat Plus™ For Dogs can also be used on breeding, pregnant, and lactating bitches.
Do not allow your dog to ingest this product. Do not apply to dogs weighing less than 23 pounds (0.045 fl. oz).
Do not use more than one applicator per dog. Weigh your dog to be sure you are applying the right dose formulated for the weight of your dog.



HOW TO OPEN:

-  Tear through perforation.
-  Fold back the safety tab.
-  Cut with scissors to open applicator.

HOW TO APPLY:
To apply SteelCoat Plus™ for Dogs: Your dog needs to be dry at the time of application and remain dry for 24 hours after application. Place applicator tip through dog's hair to the skin level between the shoulder blades. Squeeze applicator, applying entire contents in a single spot to the dog's skin. Avoid superficial application to the dog's hair. Allow area to dry before touching treated area. Do not apply more than one applicator per dog per treatment regardless of the dog's weight.


FREQUENCY OF APPLICATION
Fleas: When used monthly, SteelCoat Plus™ for Dogs breaks the flea life cycle and controls fleas, flea eggs, and flea larvae on your dog for up to three months. Although SteelCoat Plus™ for Dogs can control fleas for up to three months, if there is a high risk of re-infestation of fleas on your dog or if the dog has fleas which may cause flea allergy dermatitis, apply this product once a month.
Chewing Lice: SteelCoat Plus™ for Dogs kills chewing lice for at least one month. For best control of chewing lice, apply once every month.
Sarcoptic Mites: Applied once a month, SteelCoat Plus™ for Dogs aids in the control of sarcoptic mange mite infestations.
Do not reapply SteelCoat Plus™ for Dogs for 30 days.

Ticks: SteelCoat Plus™ for Dogs kills larva, nymph and adult ticks that may transmit Lyme disease, Rocky Mountain Spotted Fever, ehrlichiosis, babesiosis, and anaplasmosis for at least one month. For best control of ticks, apply once every month.

STORAGE AND DISPOSAL
Do not contaminate water, food, or feed by storage or disposal.
PESTICIDE STORAGE. Store unused product in original container only, out of reach of children and animals. **PESTICIDE DISPOSAL. If partly filled:** Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain.
CONTAINER HANDLING. Nonrefillable container. Do not reuse or refill this container.
